- Alumni may meet their teachers in the campus after taking appointment from the concern authority.

- ➤ Alumni in Waiting in groups and talking entering the campus entertained only with the prior permission in the campus.
- Alumni shall not take part in any anti-social activities and influence the students in any kind.
- ➤ Alumni shall donate the furniture, books and any property to the organization with great care and consideration for the institution they studies.
- ➤ Alumni Students will not hold any meetings or collect funds without the permission of the management.
- ➤ Alumni Students are expected to adopt modest style of life and set as an example to the society at large.
- ➤ Alumni must not miss use or damage the goodwill of the institution.
- ➤ Alumni may create the repository of their won learning resources to their friends and VET.
- > Alumni must not collect any kind of fee unofficially from any one.
- ➤ Alumni must audit their financial account under the banner of their own registered association
- ➤ Alumni have ever power to choose their own leader to their association.
- ➤ Alumni may provide prompt feedback for the improvement of the students.

AIMS AND OBJECTIVE

- a) To promote a brotherhood among the members.
- b) To bring the old students in touch with the present students.
- c) To create foster and create union, friendship and fellowship among the old students of the college.
- d) To encourage and foster the interest of old students in the present day activities of the college.
- e) To provide inspiration and guidance to the students of the college, through the experience and achievement of the old students.
- f) To co-operation with college management for the betterment of the college and students.
- g) To arrange and to provide charitable to the deserving needy students of the College and to render financial or other aid towards widening the scope of usefulness of the College whenever necessary.
- h) To the celebration of the parent students day annually.
- i) Servicing as forum to promote and foster the relationship between the alumni, the present students, the staff and the management of college with basic objects of exchange of ideas, which decides being mutually beneficial, will generally help in achieving excellence and professional competence and contribute to improve the quality of life.
- j) Conducting technical update programs, arrange lectures by eminent person, circulating NEWSLETTER periodically that is necessary from time to time, to maintain continuous contact and fellowship with present and future ALLUMNI.

- k) To arrange cultural, literacy and sports activities amongst alumni.
- 1) To institute scholarship revolving loan fund prizes/medals etc., for the deserving students.
- m)To bring about contact between the past and present students by holding periodical Alumni day celebrations and any other means as may be decided upon by the association from time to time.
- n) To institute and award fellowships, scholarships stipends, travel grand are otherwise supports students and research scholars to encourage them to devote themselves to scientific purists.
- o) To promote overall academic activities of the college
- p) To organize program, this inspires and motivate the young students to develop interest in any subject.
- q) To arrange and hold seminars, conference, symposia, lectures workshops and similar academic activities.
- r) To honor and present awards to distinguished Alumni of the department.
- s) To establish museums, displays and other means to create awareness among the public and to keep them abreast of the complex scientific developments in those subject which have far-reaching effect on association.
- t) To undertake training and other related programs to disseminate information on the subject of First Grade College and other scientific and social organizations.
- u) To undertake or to do all other things, which may include similar corresponding, supporting co related, incidental,

necessary matter which may be formed by the executive committee from time to time to be conductive for the achievement of all or any of the object stated above.

- v) The income of the association by whatever means shall be utilized for the objects of the association and shall not be distributed among its members or anybody.
- w) The Secretary of the association is authorized to correspond with the Registrar societies.

MEMBERSHIP

Any person aged above 18 years and obtained and pays prescribed life membership subscription and fees, as applicable, shall be eligible to become a member of Association.

- The association membership shall be as follows Life membership fees `. 1000/- Annual Membership Fees `.100/-
- ➤ All members of the Association are eligible to vote and contest to managing Committee in the General Body Meeting.
- ➤ If the subscription of the member is in arrears for more than 3 months without satisfactory explanation to the Secretary, his/her name will be removed and the executive committee may reconsider his/her application for readmission of membership.
- ➤ The termination of membership, the member acting against the objects of the association unsound my and other reasons stated by executive committee.
- ➤ All members may take part in the proceedings of the general meeting. Only such members who have completed minimum period of 6 months as members shall exercise their vote.

INFORMATION REQUIRED BY THE MEMBERS

Any member of the association may apply to the Secretary for any information as may be required or any matter of the subjects or rules and regulations of the association.

GENERAL BODY AND OTHER MEETING

- ➤ A general body meeting of the association will be held annually during the month of June.
- ➤ The report of management of the previous year working and the audited accounts for 1 period and proceeding year shall be discussed and submitted for conformation.
- ➤ An executive committee consisting of 7 members shall be elected in the general body meeting once in 3 years.
- ➤ The Secretary may call for general body meeting for which 21 days' notice shall be given to the members.
- ➤ The executive committee shall meeting once a month for which the Secretary shall give notice of 7 days to the members.
- ➤ Voting shall be conducted by showoff hand of secret ballot.
- ➤ 21 days clear notice for the annual general body meeting and 21 days' notice for the general body meeting shall be given, and the subject matters to be discussed shall be stated in the notice.
- ➤ Special general body meeting shall convene as per Sec.11 (3) of the K.S.R Act, 1960.

QUORUM

The quorum of the general body meeting shall be 2-3 of the total membership of the association

ACCOUNTS

- ➤ The official year of the association shall be 1stb April to 31st march.
- ➤ The assets and liabilities the balance sheet of the association shall be and laid before the annual general body meeting for conformation.
- ➤ Such a balance sheet and the list of committee members shall be field with the registrar of societies as per Sec.11 (3) of the K.S.R Act, 1960.

AUDITOR

An auditor shall be appointed annually and the remuneration shall fixed by the members in the Annual General Body Meeting.

EXECUTIVE COMMITTEE

- ➤ To ensure and promote the primary aims and objectives of the Association.
- ➤ To publish Annual report/Accounts.
- ➤ To operate fund and manage the property of the association and to present the duly audited accounts at annual general body meeting.
- ➤ In the event of any office Bearer laying down office for whatever reasons, managing Committee can co-opt any member consider suitable for the office for the remaining period of the tenure or till election are held.
- > To ensure utilization of income towards promoting the objective of the Association.

- ➤ May decide to expel the member of managing committee or member of the Association in case any 1 is convicted of any criminal offence, or prove insanity or member's action in contravention to the byelaws.
- ➤ To accept from government, non-government, local Bodies, Societies, NRI, Banks (nationalized/co-operative) and individual grand's, Donations, Loans, Subscription, or any property moveable or immovable for furtherance of the objectives of the association.
- ➤ At any meeting of the Executive Committee each member present will have 1 vote except the present who shall have in addition a casting vote. Voting may be rising of hand or secret ballot.
- ➤ To ensure that all monitory transaction are through objectives of the Association.
- ➤ Managing committee shall have power to appeals and raise funds and fulfill and formalities incumbent upon it.
- Executive committee may appoint a committee, subcommittee with such powers deemed fit by this body for the purpose of incommensurate with objective. The committee, subcommittee may co-opt persons who are members of the association.
- Executive committee may invite to their meeting not more than 2 specialists /experts who may be non-members of the association, whose presence with the deliberations is considered useful.
- ➤ The Association may open a bank account in any of the scheduled banks/nationalized/cooperative banks which account shall be operated under the joint signatures of any 2 of the following

The following are the Secretary Jointly with the Treasurer or any person delegated by either of them.

- ➤ The executive committee shall arrange for the publication in any manner association journal, documents as may be considered fit in the furthermost of its objectives.
- > To make the Rules and Bye laws and get approved.
- ➤ To acquired or purchase, take on lease, hire or by gift or otherwise and hold any movable or immovable property/properties or any right or privileges that may be deemed necessary or useful for the advancement of the objects of the association.
- ➤ The government body shall not admit members during the last 3 months of its tenure.

ELECTION

Any member who is desirous of standing for the election as a member to the council of management shall be member of the Association for at least 12 months prior to the date of nomination.

- ✓ Any vacancy that may arise on the executive committee may be filled in by the remaining committee members.
- ✓ Any member of the executive committee being absent for 3 successive meetings without proper calls shall cease to be a member of the executive committee.
- ✓ The executive committee is to meet every month or earlier is any business to consider any secretary shall convene such meetings 2/3 shall quorum.
- ✓ The executive committee in its meetings shall consider the entire question affecting business that may be interest to the members of the association and they shall inform and circulate any information, which may be of use to the members.

EXECUTIVE POWERS OF THE COMMITTEE:-

The administration and management of the association shall waste in the executive committee consisting of seven members including president, vice president secretary treasurer and executive committee member of the association.

PRESIDENT

He/she shall be in overall charge of the association and the General Body Meeting. All the policies and programs shall be formulated and implemented only through him or her.

VICE PRESIDENT

He/ she shall assist the president in general in the absence of the president he or she shall assume the charge of president.

SECRETARY

The secretariat shall call meeting of the executive committee whenever necessary for the transaction of the business before them and shall arrange special meeting when required to do so by any 5 members there of specifying the business of the transacted provided at least five days' notice is given. The secretariat shell with the content of the executive committee convince meeting of the general Body of the association whenever necessary. The executive committee whenever it is considered is necessary may decide to be the General Body Meeting and the secretariat shall convince in IT persons of that decision and maintained the Minutes book and record of all the proceedings of the meeting he or she shall be the correspondent of dissociation and Shelby in charge of the office with all the records of the association. And any legal disputes /questions from court / Commission, government authorities or any public will be attended answered on behalf of the association. He or she shall be the custodian of all articles and belonging with movable and immovable of the association. He or she shell file with Registrar of societies, Bangalore relevant records of the association for every year stipulated time without fail. Any other powers and trusted by the executive committee by resolution.

TREASURER:-

Treasurer will issue official effect of all types of monetary or non-monetary donations, give the membership, fees contributions et cetera and all the collection shall be deposited promptly within 3 days with such bank for banks for decided by the executive committee and submit reports to the next executive committee meeting.

The treasurer shall remain maintain all the accounts and take steps of audit of dissociation as per the prevailing rules in time and submit report to the meeting.

Committee members will be participated in meetings and will join office bearers while availing to decision in such meeting.


GLIMPSE OF ALUMNI MEET "MITRA"-2021








VET FGC ALUMNI Experience survey was conducted, asking the alumni fraternity some of the most basic questions which confounds the student mind.


The results of the survey are presented here and can be considered as evidence in making decisions about their career. Feedbacks were collected from 8 alumni.






62.5% of Alumni indicated that admission procedure is **very good** and 37.5% of Alumni indicated that admission procedure is **excellent.**




75% of Alumni indicated that fee structure and environment is **very good** and 25% of Alumni indicated that fee structure and environment **good**.








