- The inspection started on 21/12/2020 at 2.00 p.m. in FGC Board Room. The verification Officer Smt. Shwetha.S, enquired about the Caseworker to show details about only Fee concession amount received from Backward Welfare Department by the college from 2013-14 to 2019-20.
- Smt. Shwetha.S, checked information regarding OBC scholarship online application verification details of students who have applied for scholarship under OBC category. She also verified the amount sanctioned by the OBC department, amount credited to our Institution account and amount disbursed to students of Under Graduation & Post Graduation Courses.



➤ This statement was compared with the statement brought by the verification officer from the department and after verification the following points were noticed & discussed.

1. There was no amount sanctioned for the year 2013-14 as students did not apply for the scholarship in that year.
2. For the years 2014-15 to 2019-20 the amount mentioned as per statement tallied with the statement showed by the college except for the year 2016-17 which showed a difference in the amount.
3. For the year 2016-17, Smt. Selvi.S mentioned that the different is due to 1 student where scholarship was not sanctioned and other 2 students whose scholarship was sanctioned but the amount was not yet credited to college account. Smt. Selvi.S showed documents relating to the same which was accepted by the Verification Officer.
4. Smt. Shwetha.S also verified all the sanctioned amounts, disbursement statements & acknowledgements for the years 2013-14 to 2019-20.
5. They also verified all the registers & statements and took Xerox of the same from 2013-14 to 2019-20.

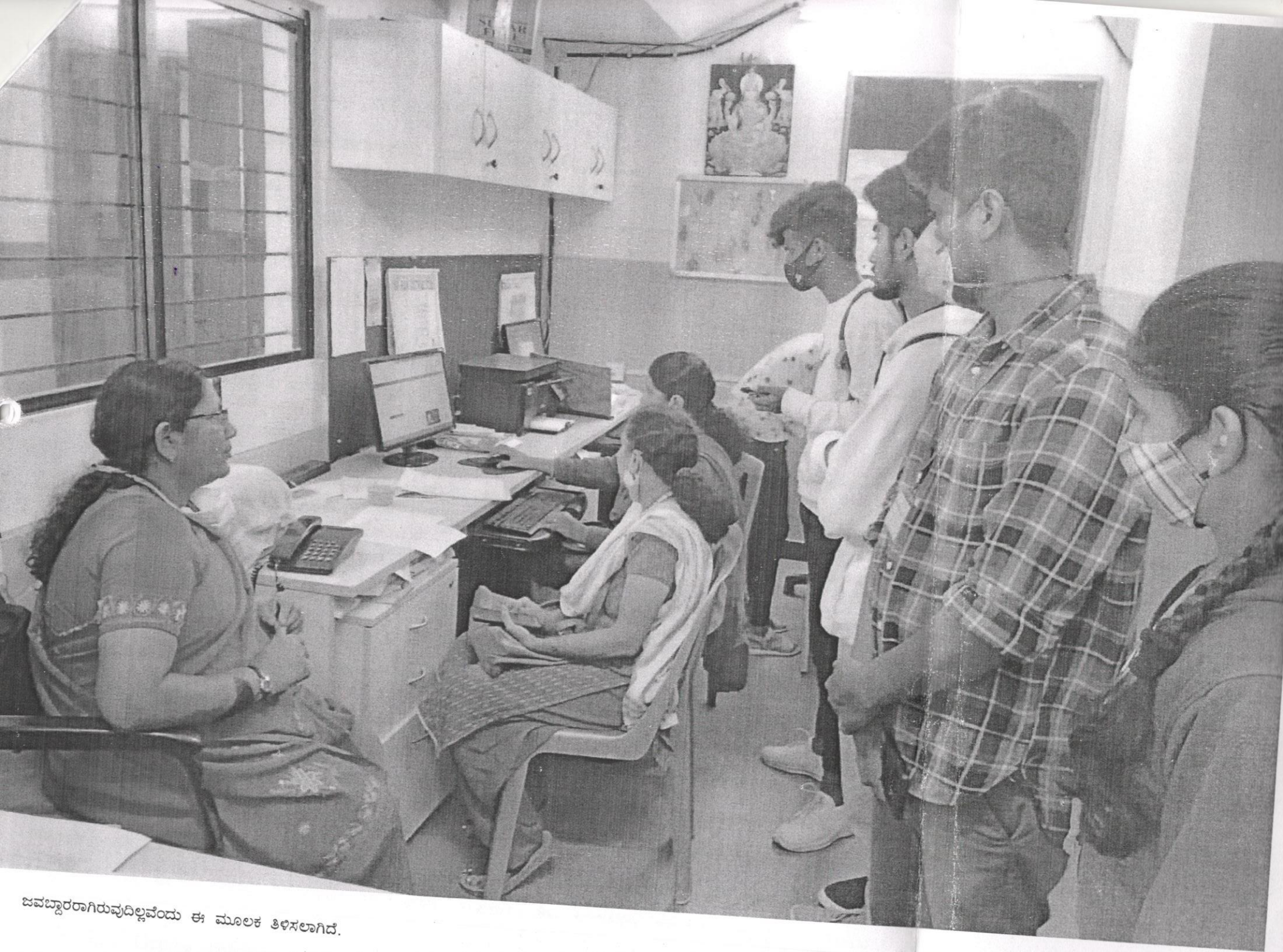



- Sri. Sunil briefly explained about students opting for Master Course & Ph.D abroad, students can get full scholarship through Prabhutha Scheme, Govt. of Karnataka. for three years in hostel they can get another 10% discount. For physically challenged students they can get 33%. The students should have scored minimum 55% marks in UG courses. The foreign student's scholarship season will be applicable throughout the year and scholarship will be confirmed for one child per one family. The students should have studied in Karnataka for minimum of seven years.
- Sri. Manoj .M. Koushik, SSP Portal Project Manager briefly explained about how to apply Kudumba ID , and it have been made compulsory from 2021-22 for applying scholarship. Adhaar seeding for submission is compulsory. In Kudumba ID parents adhaar details is necessary. For C M Nethraavidhyanidhi scheme, kudumba ID is required as per Govt. of Karnataka Order. If the students have Ration Card no need to have kudumba ID
- Bonafide data from University is mandatory & BCU result.
- The family income for SC/ST/C-I students should be below 2,50,000/- & other category, Minority students should be below 1,00,000/-The amount disbursed for student from Central Govt. 60% & the State Govt. 40%.
- The students can apply for minimum three scholarships in a year. More than fifteen types of scholarships are available for all the students,. The scholarship is available like Chief Minister Raitha Vidhyanidhi , The CMRVN Scheme for Agriculture Department ,Agriculture land, Handloom, Power Room, Nekka Vidyanidhi, Passenger Gab Driver, C M Sarige Vidhyanidhi, C M Meenugari Vidhyanidhi, Landless Labour, Narake Kadu, Agriculture department,

construction work & etc..



- While filling the application for any wrong entry, withdrawal option is available. After final submission of application the student cannot withdraw. Any name correction, edit can be done through UUCMS Portal only. SSP Name & bonafide name should be same. Previous year result entry is compulsorily (semester wise)
- The day scholar, Govt. hosteller & Private Hosteller can also get hostel scholarship.
- Aadhaar Seeding & NPCI mapping is compulsory for those who have applied for scholarship under SC/ST & other category of Under Graduation & Post Graduation Courses for the academic year 2022-23.
- The following documents are necessary for applying for SSP Scholarship
  1. Caste certificate issued by Revenue Department with RD number
  2. Income certificate issued by Revenue Department with RD number
  3. Adhaar of student
  4. Adhaar of parents

5. Family ID
6. University register number
7. Seat number for KEA admitted students
8. Previous year marks card/pass certificate
9. Fee receipt
10. Stipend/non-practicing certificate (for those studying in PG Course)
11. Medical/Dental/AYUSH Courses
12. UDID number (for differently abled students)
